To All American Patriots:

Since the election I have continually heard one commonly themed question from people that are calling into talk radio and that is “What can we the people do Constitutionally to stop the corruption that we are seeing?” The answer that is given is that there is nothing Constitutionally that the people can do, except to go out and vote. This statement is technically true, because the American people do not get their power from the Constitution. The Constitution of the United States of America only serves as the foundational structure for our federal government. It details how this government is to operate and acts to limit its size and power. And what are the people to do when they can no longer have confidence in the election process? Well there is an answer to that question.

It seems that more often than not the Constitution is seen as the only founding document of this country, when in fact there are three. The first is the Declaration of Independence that declared America as a free and independent country and abolished all ties to the British monarchy. The second is the Constitution of the United States of America which describes our governmental system and exclusively delegates what powers the federal government has and serves as the supreme law of the land. This is why every elected official (even at state levels) takes an oath to uphold and protect the Constitution of the United States of America. The third is the Bill of Rights (or the first 10 Amendments to the Constitution) this came about in order to place further restrictions on the federal government and to specify and guarantee certain Rights to the American people. In fact, several of the crimes that were perpetrated by the King of England and were listed in the Declaration of Independence were the inspiration for the Bill of Rights.

Our Founders knew that at some point the American people would be faced with the same, if not greater, level of Tyranny that they experienced, because they understood that “ultimate power, ultimately corrupts”. So in their (I believe divinely inspired) wisdom they built in a safeguard for future generations to use in order to cast off the chains of Tyranny that the American people would inevitably find themselves shackled in. All three of our founding documents are instrumental

to the cause of Freedom and each one contains a piece of the puzzle to this safeguard that was left behind by our Founders. For as much as we hear about “our democracy” we are a **Republic**, which is guaranteed by the Constitution and as such **All** political power is derived from the people, this is one of the reasons why the Constitution starts with the words “We The People”. While the Constitution and the Bill of Rights are extremely important documents to this safeguard and help to preserve Freedom and Liberty for the American people, this is only achieved when these documents are followed. But what are the people to do when these documents are not being followed and elected officials of their own government are no longer keeping their oaths of office and their actions have become destructive to the Rights, Liberties and Freedoms of the American people? Well there is something that the people can do and that answer lies within our most overlooked founding document The Declaration of Independence.

“The Declaration of Independence”

“WHEN in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the Powers of the earth, the separate and equal station to which the Laws of Nature and of Nature’s God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are

accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security. Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States.”

Many people often quote the line “We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.”, but if this one line still holds merit, then doesn’t the rest of the document as well, the answer is yes. It is the sole purpose of our Government to secure and protect these Rights and to do so with the consent of the governed or by the will of the people. It was the belief of our Founders that people should be Free, that it was **the Right and the Duty of the people to Alter or Abolish Any Form of Government** when it has become destructive to those ends and for the people to institute or form a **New Government** and to base it on such principles and organize its powers in such a way that it shall seem most likely to guarantee their **Safety and Happiness**. Abolishing one’s own government especially one that is long established is a drastic action to take and implementing such change should not be done for causes or actions that are minor or short lived. History shows us that people are willing to suffer through hard and difficult times while they are tolerable, because it is far easier than changing the form of government that they have become accustomed to. But when continual abuses and usurpations have clearly shown that they are all for one common objective and that is to bring the American people under a Tyrannical rule, when the American people are faced with the reality that their own government has become corrupted and destructive to their Rights, their Freedom and to their very Security, **it is not only their Right but it is their Duty to throw off such a Government**. Our Founders believed that they had the power to sever all ties to the British Empire the most powerful in the world at that time and form a New Government because they watched as their Rights and Freedoms were stripped away by the tyrannical dictatorship of the King

of Great Britain and they were not willing to live under Tyranny. We are seeing these same destructive behaviors taking place today and we have the same power that our Founders had.

While the abuses and usurpations of the Rights and Freedoms of the American people are long and numerous and go back for over a century, one only has to look back at the last year to see an inexcusable and Tyrannical amount of these crimes taking place.

We have witnessed a complete disregard for the Rights of the American people and have watched as our Freedoms have been stripped away. We have had Governors acting under Unconstitutional “emergency powers” and illegally closing small and private businesses while leaving large corporations open and even violating the separation of church and state by demanding that churches close.

We have seen the Unconstitutional or illegal changes made to election laws in several states that has resulted in the destruction of the people’s belief in the process of free and fair elections.

Over the last year we have been forced to watch as domestic terrorist committed acts of insurrection, as they called for the destruction of America while burning and looting cities across this country directly threatening the security of the American citizens. All while costing billions of dollars in damages, destroying the livelihood of countless individuals, actively working to tear down and destroy our history and costing the lives of far too many innocent people. We have listened as these same individuals have been praised by elected officials and members of the so-called media who have even raised money in order to bail these traitors out of jail. Meanwhile, those of us who stand up in defense of our country and believe in our founding are vilified and demonized as the “real traitors”.

We have elected officials that take an oath to uphold and protect the Constitution of the United States of America and see this as nothing more than a formality. They claim to be fulfilling their “oath” when it suits their agenda, but ignore the Constitution when it stands in their way. These elected officials do not get to pick and choose when they follow the Constitution or what parts of it apply. The Constitution is the only document that gives these elected officials a position in our

government and if the Constitution no longer applies then they can all go home. An oath is not a formality; it is a sacred promise or an act of pledging an allegiance to something, like one's country, or in the case of our elected officials to the Constitution of the United States of America. This is not a small or insignificant act for these individuals to break their oaths of office; it is an act of disloyalty toward the American people and an act of treason to the Constitution.

We have "elected representatives" that are supposed to be the authors of law in our government. Yet they fail at their number one task, instead passing their duties off to unelected bureaucracies and lobbyists to write bills and then vote and pass these "laws" without even reading them and if there is something in these bills that negatively affects them, these "political elites" exempt themselves from the law while preaching to the American people how "No one is above the law".

For years our government has shown a blatant disregard for the tax dollars that are collected from the American people. Through unfunded liabilities including forever pensions for politicians and their families the American people have been burdened with an insurmountable amount of debt as politicians have spent this country into bankruptcy. For years politicians have enriched themselves and their families through their political offices while pushing more and more of the American people into abject poverty. Countless tax dollars have gone to personal pet projects of politicians and have even been recklessly spent funding countries that are enemies of the United States.

We have seen a complete breakdown of our judicial system in this country and this has become very evident in recent years, with the corruption reaching to the highest levels, the Supreme Court. This is not just another court, the Supreme Court makes up one-third of our federal government and their only job is to make sure that the Constitution and the rule of law are followed. Yet through corruption and political opinion most Supreme Court Justices time and again have failed to accomplish this simple task.

We have also seen the development of a two tier justice system in this country, one that portrays those who believe in the founding principles of America as

violent and racist offenders, while failing to prosecute real criminals, especially those within the so-called “ruling class” of the “political elites”.

There are so-called “elected representatives” that are supposed to be in office to perform the will of the people. Yet evidence shows that these individuals do anything but represent the people, instead representing their own self-interest. Including using the impeachment clause of the Constitution as nothing more than a political tool; they have taken something that is only supposed to be used in the most drastic of circumstances and turned it into a threat and use it as political leverage.

We have a “news media” in this country that has declared an information war against the American people. Under the guise of the First Amendment these outlets spread nothing but lies, misinformation and propaganda in order to push their own political agendas and use their platforms to fan the flames of hatred and racism in order to further divide this country every chance they get. The media is not alone in committing these crimes as several of our own “elected officials” use these same tactics against the American people.

It is the Right of the people to be able to protest and petition their government, but in recent times those protests and petitions have gone unheard and/or ignored.

Life is the most fundamental Right that is given to any person by their Creator. Yet we have seen as this most sacred of Rights is robbed from the most innocent among us. No moral society can survive when it celebrates the slaughter of its own children.

These examples above are but a small handful of the many abuses of power, usurpations of the Rights, Liberties and Freedoms and crimes committed against the American people. Our Founders were seen as committing an act of treason all because they believed in the cause of Freedom. And upon declaring that Freedom they were immediately force to fight a war, not that they wanted to but because they had to in order to defend their Rights and if they had failed they would have been put to death for their actions. In the past there are people who have praised our Founders for their brave actions, which at times became destructive like the Boston Tea Party, because the fight for Freedom isn't always peaceful, it comes

with a price, but those same people would be condemning our Founders today. Our Founders knew that We The People would be faced with such challenges. This is why they put in place this safeguard, so that We The American People could take back our country and our government without having to go to war like they did. Evil uses violence and destruction to intimidate and instill fear in the general populace in order to keep them oppressed, because they are easier to control, to manipulate and to rule over. Good uses violence not because it wants to but because it has to, in self-defense and in order to preserve everything that it holds dear.

The American people are left with two choices either we give up our Rights and our Freedoms and live under a Tyrannical government that does not follow the morals and principles that are laid out in our founding documents or We The American People can use the tools that were left for us by our Founders to defeat Tyranny. We are given the ability to accomplish this goal peacefully and we can go about it in one of two ways, one is for the several states that believe in Freedom, Liberty and the founding of this country to band together and abolish their form of government and secede from the Union by forming a **New America with a New Government** and leaving the corrupt states to fall and crumble under the weight of their own Tyranny. You would hear many people, even conservatives, call this an act of treason, but isn't that exactly what our Founders did when they seceded the American Colonies from the British monarchy. The other is for the American people to alter their current form of government and declare that it is null and void and the members of **Our** government can recognize that this is the consent of the governed and step down.
